Jetfloat Product supplied under this warranty are manufactured from the best quality materials and are warranted by Jetfloat, the manufacturer, to the Original Purchaser (“Purchaser”) against defects in materials and workmanship, as specified under this limited warranty, occurring as a result of the manufacturing process during the stated time period, under normal use and service, subject to the terms and conditions contained in this 25 year limited warranty. Warranty is not transferable to anyone who subsequently purchases Products from the Purchaser, or to any subsequent purchaser.

1.1. Conditions

The Jetfloat warranty is strictly subject to the conditions set forth below which form an integral part hereof.

a. 4.2. Coverage

a. Any defect such as cracks, breakage, leaks, and ultraviolet deterioration caused by defects in material and manufacturing workmanship from normal dock use, under normal weather / sea / lake / river conditions, with less than 1m / 3ft high waves. Jetfloat Accessories can withstand very harsh weather conditions without any damages however, if your dock may be exposed to weather conditions outside of the scope of this warranty or if you are planning on using it for another purpose other than the intended use, please contact us directly for more information on how the warranty may be applied or voided.

b) This limited warranty extends only to the Purchaser of Accessories from Jetfloat directly, an authorized Jetfloat dealer. Warranty is not transferable to anyone who subsequently purchases Accessories from the Original Purchaser, or to any subsequent purchaser.

c) This warranty is only valid for Accessories purchased after February 1st, 2022. For purchases prior to this date please contact our office for additional details.

4.3. Duration

10 years if used in a system as per section 1 or 2 of this warranty statement, beginning on the date of purchase from Jetfloat directly or an authorized Jetfloat dealer. This warranty is prorated based on time in use. It will apply at the following percentage rates in relation to years from purchase:

0 to 2 years: 100 %, 3 to 4 years: 85 %, 5 to 6 years: 75 %, 7 to 8 years: 65 %, 9-10 years: 50 %

5 years if used in a system as per section 3 of this warranty statement, beginning on the date of purchase from Jetfloat directly or an authorized Jetfloat dealer. This warranty is prorated based on time in use. It will apply at the following percentage rates in relation to years from purchase:

0 to 1 years: 100 %, 2 to 3 years: 75 %, 3 to 4 years: 50 %, 4 to 5 years: 25 %, 5 to 6 years: 15 %, 6 to 7 years: 10 %, 7 to 8 years: 5 %, 8 to 9 years: 5 %, 9 to 10 years: 5 %

4.4. How Warranty Applies

If your Jetfloat Accessories are deemed defective, Jetfloat will repair it, or at our choice, replace it. If we decide to repair your Accessories, we may use new or reconditioned replacement parts or a new or reconditioned Accessories of the same or equivalent design. If it is determined that the Accessories must be inspected by an authorized Jetfloat representative to verify claim the cost of shipping product to Jetfloat will be at the Purchaser's expense. If replacement Accessories, new or otherwise will be provided as part of a claim the cost of shipping Accessories to the purchaser will be at the Purchaser's expense.

4.5. Limitations

JETFLOAT WILL NOT PAY OR BE HELD RESPONSIBLE FOR: INJURIES INCLUDING DISMEMBERMENT or DEATH, LOSS OF TIME; INCONVENIENCE; LOSS OF USE OF YOUR JETFLOAT ACCESSORIES OR PROPERTY DAMAGE CAUSED BY YOUR JETFLOAT ACCESSORIES OR ITS FAILURE TO WORK; ANY SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES; OR ANY DAMAGES RESULTING FROM MISUSE OR MODIFICATION OF YOUR JETFLOAT ACCESSORIES.

4.6. Claims

a. If a Jetfloat Accessory fails under normal use and within the applicable warranty period, the Purchaser must submit a written claim to Jetfloat's head office at office@jetfloat.com, using the appropriate WARRANTY CLAIM FORM. Claims must identify the failed Accessories, describe the claimed defect(s), and include copies of dated proofs of purchase/receipts from Jetfloat or a authorized Jetfloat Dealer. "Repair" may be limited to providing a repair kit to Buyer.
